

DREF operation update Guatemala: earthquake

The International Federation of Red Cross and Red Crescent (IFRC) Disaster Relief Emergency Fund (DREF) is a source of un-earmarked money created by the Federation in 1985 to ensure that immediate financial support is available for Red Cross and Red Crescent emergency response. The DREF is a vital part of the International Federation's disaster response system and increases the ability of National Societies to respond to disasters.

Period covered by this update: 10 November to 31 January 2013.

Summary: 309,147 Swiss francs were allocated from the IFRC's Disaster Relief Emergency Fund (DREF) on 10 November 2012 to support t he Guatemalan R ed C ross (GRC) in delivering as sistance t o s ome 6,000 beneficiaries, and to replenish disaster preparedness stocks.

On 7 N ovember an e arthquake of magnitude 7. 2 o n t he R itcher s cale hit the northwestern G uatemalan c oast. Government figures state that the homes of 26,010 persons were severely affected or des troyed, while 1,300,000 per sons were i ndirectly i mpacted by t he earthquake.

With the support of the DREF and other Red Cross partners, the Guatemalan Red Cross has been able to reach over 3,000 families with relief items and over 4,000 persons with psychosocial support, violence prevention ac tivities and epi demic control and h ygiene pr omotion. A dditionally, 4,458 families were reached with safe water. However, with many actors targeting shelter needs and a new government plan to support the construction of some 3,000 homes, the National Society is now changing its strategy to more effectively use DREF funds. After food security warnings from different institutions, the Guatemalan Red Cross carried out special assessments to target vulnerable families with food parcels to avoid the exacerbation of already existing malnutrition in the region. As a result, the current update has a budget revision to reflect this change in strategy.

Due to the extension for an ad ditional 30 days of the state of emergency and the fact that the food insecurity situation was aggravated as result of the earthquake, the GRC has requested the extension of the DREF implementation timeframe for additional 30 days to continue their support as auxiliary to the government. This operation is now expected to be implemented in four months, and completed by 10 March 2013. A revised budget for this DREF operation has ben drawn up and can be seen below. In line with Federation reporting standards, the final report (narrative and financial) is due 90 days after the end of the operation (by 10 June 2013).

The major donors and partners of DREF include the Australian, American and Belgian governments, the Austrian Red Cross, the Canadian Red Cross and government, Danish Red Cross and government, the European C ommission H umanitarian Aid a nd Civil P rotection (ECHO), the I rish and the I talian governments, the Japanese Red Cross Society, the Luxembourg government, the Monaco Red Cross and government, the N etherlands Red Cross and government, the N orwegian Red Cross and government, the Spanish Government, the Swedish Red Cross and government, the United Kingdom Department for International Development (DFID), the Medtronic and Z Zurich Foundations, and other corporate and private donors. The situation

An earthquake of magnitude 7.2 on the Richter scale occurred on 7 November 2012 at 10.35 hours local time off the coast of Guatemala, near the border with México. It had a depth of 33.2 km, and was felt across the country within a radius of 200 km from the epicentre.

A report from the National Coordinator for Disaster Reduction (*Coordinadora Nacional de Reducción de Desastres*, CONRED) on 14 November 2012 stated the following figures on the impact of the earthquake:

Through Governmental Decree No. 3-2012, the president of Guatemala declared a state of emergency on 7 November for the departments of Retalhuleu, Quetzaltenango, Sololá, Quiché, Totonicapán, San Marcos, Totonicapán, and Huehuetenango. This Decree allowed for faster purchase and delivery of assistance by the governmental authorities. On 5 February, the state of emergency was extended for 30 more days through decree No. 2-2013.

As part of the government response to the emergency, the Ministry of Social Development started a National Housing P lan with the g oal of building 3,000 new houses for the families that I ost their homes. The construction of the first 1,400 homes in S and M arcos is starting in February 2013. Additionally, the Inter-American Development Bank has offered support for the reconstruction plans.

Coordination and partnerships

The G uatemalan R ed C ross actively c oordinates with C ONRED through its system of inter-institutional liaisons, maintaining close working partnerships with the Ministry of Public Health and Social Assistance. Similarly, the N ational Society participates in the coordination meetings of the Guatemalan Humanitarian Network, participating in its technical clusters of shelters, health, water, sanitation and hygiene promotion, and food security.

Additionally, in coordination with the Guatemalan Red Cross leadership, the International Committee of the Red Cross (ICRC), the Netherlands Red Cross, the Norwegian Red Cross, and the Spanish Red Cross supported the assessment, implementation and monitoring of the affected areas, providing financial support to assist vulnerable families. In support of the National Society's efforts, the IFRC country coordinator joined the discussions and analysis with the National Society, while an emergency health delegate and a disaster management delegate from the disaster & rrisis response and early recovery unit were deployed to support

the damage and needs assessments. In addition, the unit's virtual EOC was activated to support meetings between the National Society, the secretariat and Partner National Societies.

At local Level, members of the National Intervention Teams coordinated with the Local activities to as sist families in 15 c ollective centres. Information on their action was shared within the departmental EOC to ensure all actors providing response had enough information to avoid the duplication of efforts. Due to the damages to the San Marco branch building, a base camp was set up to direct all analysis and proposed actions.

Red Cross and Red Crescent action

As a result of monitoring the situation in the region, the actions carried out by other partners and the support from other Movement members, the National Society is proposing modifications to the DREF supported operation. As the shelter needs were being covered by other actors, the Guatemalan Red Cross will now distribute food parcels to 1,000 affected families whose livelihoods were affected. Additionally, water filters will also be provided, as many systems have not been yet re-established and safe water will need to be guaranteed for several months. The objectives in the area of health for 1,000 families to reduce the risks of outbreaks of epidemics have not undergone any changes.

Progress towards outcomes

Relief distribution

Outcome: The Guatemalan Red Cross contributes to meet the immediate needs of 1,000 families in the departments of San Marcos and Quetzaltenango

Outputs and activities planned:

- Conduct emergency damage and needs assessments alongside government authorities and other humanitarian partners.
- Hire a helicopter to complete a rapid assessment of large-scale damage.
- Develop a beneficiary communication plan with affected communities to ensure their participation throughout the process.
- Develop a beneficiary targeting strategy and registration system to deliver intended assistance to affected families together with affected communities and their leaders.
- Replenish pre-positioned stock used during the emergency
- Support the distribution of non food relief items to 450 families and the distribution of food parcels for 1,000 families.

Progress: As part of their overall relief efforts the National Society, with the support of Red Cross partners has as sisted 1,005 families with blankets, 1,279 with hygiene kits, 3,889 with food parcels and 299 with mattresses. With the extension of the state of emergency by the governmental authorities, the GRC continues with their assistance to affected families.

The selection process of beneficiaries had clear criteria to follow in order to ensure that the most vulnerable persons would be reached: homes headed by single women, elderly people, homes with children under five, persons with disabilities, and people living with HIV-AIDS.

A special assessment process was carried out to determine and monitor the evolving needs of the affected population, particularly related to their vulnerability to risks and their food security, looking at the nutritional intake of family members and access to different food sources. The information compiled by the National Society, in addition to that shared by other organizations in country, determined that the earthquake exacerbated the situation in the affected area, prompting a re-evaluation of the GRC plan of action. As a result, the National Society is now proposing the distribution of the following food parcels to alleviate the situation:

During the tendering process of the food parcels, the National Society will require providers to ensure that:

- All products should be in good and marketable conditions.
- Following the Cartagena Biosecurity Protocol, all products should indicate if the food contains any Genetically Modified Organisms (GMO).
- The name of the product, its production and expiry dates must be clearly indicated in each package.
- Have an expiry date of at least one year (with the exception of the rice).

As part of the DREF support, 1,000 families will be receiving two food parcels to cover their needs and help to lessen the burden of those families who are hosting additional persons, for two months.

Emergency health, water and sanitation

Outcome: 6,000 persons (1,000 families) affected have access to pre-hospital care, information on epidemic control, a campaign against malnutrition, psychosocial support and violence prevention activities.

Outputs and activities planned:

- Support rescue and evacuation efforts.
- Provide first aid care to the affected population and ensure referral and transfer services to health centres.
- Provide psychological first aid and psychosocial support to persons (including affected volunteers) in the San Marcos region.
- Provide violence prevention messages to communities (including affected volunteers and migrants) in

affected regions.

- Conduct community training on epidemic control (main focus on acute respiratory infections) and on good nutritional practices for children under five, including indigenous communities.
- Distribute safe water for affected people for at least two weeks.
- Carry out continuous assessments of water, sanitation, and the situation relating to hygiene.

Progress: During the period covered by the report, the GRC has reached 4,212 persons with psychosocial support and violence prevention activities and 4,195 persons with epidemic control and hygiene promotion. Additionally, 4,458 families were reached with safe water.

Trained R ed C ross v olunteers v isited 33 c ommunities and c ollective c entres in S an M arcos, T ejutla and Serchil. They completed different psychosocial support activities, including games and painting sessions with children and group session with adults to support them in their mourning process and post-traumatic stress. The activities were targeted at women, men, boys and girls in an effort to assist them with their emotional recovery, return to their normal everyday activities and reduce the risk of violent acts. These same families also had sessions on violence prevention.

In order to reduce health risks and the spread of diseases, volunteers also targeted 15 collective centres and 11 communities in the municipalities of Serchil, Tejutla, San Pedro and San Marcos with hygiene promotion and other epidemic control measures. Some of the topics discussed were the washing of hands, the means of transmission of diseases (diarrheic and respiratory) and preventive measures, and the safe use and storage of water.

As the ear thquake resulted in the collapsed of several water systems, the GRC installed three water treatment plants that reached 18 communities from 3 municipalities in San Marcos, 15 collective centres and three humanitarian institutes. Over 1, 315,300 litres were distributed over 30 days with the support of 25 volunteers from different branches of the National Society, and the activities are still ongoing. As part of the efforts, the GRC has joined the Ministry of Public Health and Social Assistance to monitor PH and chlorine levels in the water distributed to affected families. The table below indicates the number of families reached with safe water:

So far, no outbreaks of disease have been reported.

Emergency Shelter

Outcome: 300 families with damaged houses from the areas affected by the earthquake are assisted with shelter solutions

Outputs and activities planned:

- Identify communities and specific beneficiaries in coordination with local government authorities and the community leaders.
- Deploy a RIT member specialized in emergency shelter.
- Immediately provide 300 families with shelter kits (including 2 tarpaulins each).
- Assess the feasibility of the use of a cash transfer system with the involvement of the affected communities in the planning process to support 300 families with the repair of damaged houses.
- Develop analysis mechanisms to ensure inclusion of gender and violence prevention considerations during the provision of shelter solutions.
- Carry out repairs to the National Society branches affected by the earthquake to ensure their ability to function.

Progress: As mentioned in the situation section of this report, soon after the launch of the current plan of action, the government of Guatemala developed a national plan to assist affected families with their shelter needs. Therefore, the National Society analyzed the current situation in relation to gaps in the humanitarian assistance to create a new strategy to use the funds provided more efficiently. As a result, the shelter sector is now being e liminated from their plans and the funds are being redirected to as sist families with food parcels as it is feared that rates of malnutrition may worsen, particularly among small children, due to the disruption of livelihoods after the earthquake in a country already affected by the severe loss of crops for the last five years. It should be noted that the majority of the families are now staying with friends and families.

However, s everal dispensary tents were n eeded in the operation as a basec amp was installed in S an Marcos when the departmental branch building was affected by the earthquake. In addition, dispensary tents are also being used during the health activities with communities. Therefore, the dispensary tents and the repairs to the branch continue to be included in the DREF support.

Logistics

Outcome: The local logistics capacity of the Guatemalan Red Cross to respond with relief items is strengthened with the support of standardized items prepositioned in the IFRC's zone Logistics Unit in Panama as well as enhanced with technical support

Progress: Most of the relief distributions were carried out with the support of two Tropical Mobile Storage Units (TMSU) that were prepositioned in the country with the assistance of the Americas zone's global logistics service. Therefore, in support of the DREF operation the logistics service is a ssisting with the replenishment of the blankets, jerry cans, buckets, and hygiene kits used by the Guatemalan Red Cross.

Communications

Communications of ficers in the Americas zone office assisted the GRC communications department in posting three articles regarding GRC actions in response to the earthquake in San Marcos. Communications officers also supported the editing and formatting of two videos on GRC actions as well as interviews with beneficiaries. One other video of the GRC San Marcos branch of fice that was damaged is still pending approval by the National Society to be uploaded and shared. In addition, these videos and articles were promoted on the IFRC's Spanish language twitter account @ifrc_es.
